The Graduate Certificate in System Quality & Risk Evaluation is a program for students who aim to pursue a career as a Test Manager, Systems Test Engineer, Systems Integration Engineer, System Analyst, or Risk Analyst where skills will include responsibilities for planning test and evaluation activities and overseeing testing activities, designing and implementing test strategies to ensure system quality, developing and managing interoperability across systems, analyzing system qualities, troubleshooting test failures, or analyzing models and system risks.

Courses taken in the certificate program may be applied toward a master's degree in Systems Engineering, subject to restrictions outlined in GCAC-309 Transfer Credit (https://gradschool.psu.edu/graduate-education-policies/gcac/gcac-300/gcac-309-transfer-credit/). Certificate students who wish to have certificate courses applied towards a graduate degree must apply and be admitted to that degree program. Admission to the graduate degree program is a separate step and is not guaranteed.

Admission Requirements

Certificate students who wish to have certificate courses applied towards the Master of Systems Engineering must apply and be admitted to that degree program. Admission to the Master of Software Engineering graduate degree program is a separate step and is not quaranteed.
